The meeting was called to order at 10:04 am.

A motion was made by Walter Riedel to approve the minutes of the meeting held on June 21, 2018. The motion was seconded by Cheryl Zeto. All present are in favor. No one opposed. Motion passed unanimously.

## Discussion & action items:

- a) A motion was made by Sherry Jackson to accept the 2017 Audit as presented by Charles Reed & Associates. The Fund received a clean audit opinion for the period ending December 31, 2017. The motion was seconded by Walter Riedel. All present are in favor. No one opposed. Motion passed unanimously.
- b) Tim Sharpe and Jim Stoker presented the quarterly review and rebalancing for the quarter ending June 30, 2018. All of the approved changes initiated over the last six months with the investment policy and money managers are in place. The Funds' performance is experiencing positive effects by these changes. Tim Sharpe noted that the Fund's diversification is positioned to cope well with the next recession. The board members agree with the rebalancing recommendations presented by Tim Sharpe for the next quarter.
- c) Jim Stoker, with MorganStanley Wealth Management, presented the board members with a short educational session on "Asset Allocation Methodology".
- d) A motion was made by Sherry Jackson to approve the travel expenses to send Jason Maddox to the TEXPERS Summer Educational conference and Advanced Trustee training and in San Antonio, TX August 11-14<sup>th</sup>, 2018. The motion was seconded by Cheryl Zeto. All present are in favor. No one opposed. Motion passed unanimously.
- e) The Survey of Investment Experience through 2016 is a survey of the rates of return that the TLFFRA funds have experienced since 1995. This survey shows the Orange Retirement Fund to be performing well.
- f) The Pension Review Board will present a rough draft of their findings
